DRUGS AND ALCOHOL POLICY

The organization, being committed to the health, safety, security and efficiency of its employees, will consider seriously any suspicion of substance abuse related to drugs and alcohol by any employees and contractors in the line of duty.

Drugs, alcohol or other related forms of substance abuse could effect work performance and endanger other employees and assets. As such, any personnel, who in the opinion of the immediate superior, is incapable of performing assigned work or duties due to substance abuse, will be refused entry into or will be removed from the work location.

The organization reserves the right to conduct searches for possession of abused drugs, alcohol or related substances on the suspected person while in the premises.

Those workers who have a substance abuse related problem will be encouraged to seek assistance voluntarily, failing which the suspected worker will be referred to the management for further action.

Any violation of this policy will be subjected to disciplinary action, which may include termination of employment.
