Entitlement to Participate and Appointment of Proxy

- Only members whose names appear on the Record of Depositors as at **22 August 2023** shall be eligible to attend, speak and vote at the 27th AGM or appoint a proxy(ies) and/or the Chairman of the Meeting to attend and vote on his/her behalf.
- If you are unable to attend the meeting on 29 August 2023, you may appoint the Chairman of the meeting as proxy and indicate the voting instructions in the Proxy Form.
- If you wish to participate in the 27th AGM yourself, please do not submit any Proxy Form for the 27th AGM. You will not be allowed to participate in the 27th AGM together with a proxy appointed by you.
- Accordingly, proxy forms and/or documents relating to the appointment of proxy/corporate representative/ attorney for the 27th AGM whether in hard copy or by electronic means shall be deposited or submitted in the following manner not later than **Monday**, **28 August 2023** at **10.00 a.m**:

(a)	Register as a User with TIIH Online	 Using your computer, please access the website at https://tiih.online. Register as a user under the "e-Services". Select the "Sign Up" button and followed by "Create Account by individual Holder". Please do refer to the tutorial guide posted on the homepage for assistance. If you are already a user with TIIH Online, you are not required to register again.

(b)	Proceed with submission of Proxy Form	• After the release of the Notice of Meeting by the Company, login with your user name (i.e. email address) and password.			
		• Select the corporate event: "CN ASIA 27TH AGM – Submission of Proxy Form" .			
		• Read and agree to the Terms & Conditions and confirm the Declaration.			
		• Insert your CDS account number and indicate the number of shares for your proxy(s) to vote on your behalf.			
		• Appoint your proxy(s) and insert the required details of your proxy(s) or appoint Chairman as your proxy.			
		• Indicate your voting instructions – FOR or AGAINST, otherwise your proxy will decide your vote.			
		• Review and confirm your proxy(s) appointment.

	ii. Steps for Corporation or Institutional Holders				
(c)	Register as a User with TIIH Online website	 Access TIIH Online website at <u>https://tiih.online</u>. Under e-Services, the authorised or nominated representative of the corporation or institutional holder selects "Create Account by Representative of Corporate 			
		Holder".			
		• Complete the registration form and upload the required documents.			
		• Registration will be verified, and you will be notified by e-mail within one (1) to two (2) working days.			
		• Proceed to activate your account with the temporary password given in the e-mail and re-set your own password.			
		• Note: The representative of a corporation or institutional holder must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. Please contact our Share Registrar if you need clarifications on the user registration.

		•	Select the corporate exercise name: "CN ASIA 27TH AGM – Submission of Proxy Form".	
		•	Agree to the Terms & Conditions and Declaration.	
		•	Proceed to download the file format for "Submission of Proxy Form" in accordance with the Guidance Note set therein.	
		•	Prepare the file for the appointment of proxies by inserting the required data.	
		•	Submit the proxy appointment file.	
		•	Login to TIIH Online website, select corporate exercise name: "CN ASIA 27TH AGM – Submission of Proxy Form".	
		•	Proceed to upload the duly completed proxy appointment file.	
		•	Select "Submit" to complete your submission.	
		•	Print the confirmation report of your submission for your record.	

Meeting Registration

- Upon verification, you are required to write your name and sign the Attendance list placed on the registration table.
- You will be given a wristband for the purpose of voting at this 27th AGM.
- You must wear the wristband throughout the 27th AGM as no person will be allowed to enter the meeting hall without the wristband. There will be no replacement in the event you lose or misplace the wristband.
- If you are attending the meeting as a member as well as a proxy, you will be registered once and will be given only one wristband to enter the meeting hall.
- No person will be allowed to register on behalf of another person even with the original Mykad/passport of the other person.

Voting at Meeting

- The Voting at the 27th AGM will be conducted by poll in accordance with Paragraph 8.29A of Bursa Malaysia Securities Berhad Main Market Listing Requirements.
- The voting session will commence as soon as the Chairman calls for the poll to be opened.
- Upon completion of the voting session for the 27th AGM, the Scrutineers will verify and announce the poll results followed by the Chairman's declaration whether the resolutions are duly passed.
