REMOTE PARTICIPATION AND VOTING FACILITIES ("RPV")

Members are to attend, speak (including posing questions to the Board via real-time submission of typed texts) and vote (collectively, "participate") remotely at the EGM using RPV provided by Tricor Investor & Issuing House Services Sdn. Corporate representatives of corporate members must deposit their original or duly certified certificate of appointment of corporate representative at the Share Registrar's office not later than **11.00 a.m. on Monday**, **10 May 2021** to participate via RPV in the EGM.

Attorneys appointed by power of attorney are to deposit their power of attorney at the Share Registrar's Office not later than **11.00 a.m. on Monday**, **10 May 2021** to participate via RPV in the EGM.

A member who has appointed a proxy or attorney or authorised representative to participate at the EGM via RPV must request his/her proxy to register himself/herself for RPV at the TIIH Online website at <u>https://tiih.online.</u>

As the EGM of CN Asia is a fully virtual meeting, members who are unable to participate in this EGM may appoint the Chairman of the meeting as his/her proxy and indicate the voting instructions in the Proxy Form.

PROCEDURES FOR REMOTE PARTICIPATION AND VOTING VIA RPV FACILITIES

Refer to the tutorial guide posted on the homepage for assistance. Registration as a user will be approved within one (1) working day and you will be notified via e-mail. If you are already a user with TIIH Online, you are not required to register again. You will receive an e-mail to notify you that remote participation is available for registration at TIIH Online. 		
(b)	Submit your request to attend EGM remotely	 Registration is open from 10.00 a.m. Friday, 7 May 2021 until the day of EGM on Tuesday, 11 May 2021. Member(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to pre-register their attendance for the EGM to ascertain their eligibility to participate in the EGM using the RPV. Log in with your user ID and password and select the corporate event: "(REGISTRATION) CN ASIA EGM 1 2021". Read and agree to the Terms & Conditions and confirm the Declaration. Select "Register for Remote Participation and Voting". Review your registration and proceed to register. The system will send an e-mail to notify you that your registration for remote participation is received and will be verified. After verification of your registration against the General Meeting Record of Depositors as of 28 April 2021, the system will send you an e-mail after 10 May 2021 to approve or reject your registration for remote participation. (d)	Participate through Live Streaming	• Select the corporate event: "(LIVE STREAM MEETING) CN ASIA EGM 1 2021" to engage in the proceedings of the EGM remotely.		

		• If you have any question for the Chairman/Board, you may use the query box to transmit your question. The Chairman/Board will endeavour to respond to questions submitted by remote participants during the EGM. If there is a time constraint, the responses will be e-mailed to you earliest possible, after the meeting.
(e)	Online Remote Voting	 The voting session commences from 11.00 a.m. on Tuesday, 11 May 2021 or immediately after the Annual General Meeting 2021 of the Company until a time when the Chairman announces the completion of the voting session of the EGM. Select the corporate event: "(REMOTE VOTING) CN ASIA EGM 1 2021" or if you are on the live stream meeting page, you can select "GO TO REMOTE VOTING PAGE" button below the Query Box. Read and agree to the Terms & Conditions and confirm the Declaration. Select the CDS account that represents your shareholdings. Indicate your votes for the resolutions that are tabled for voting. Confirm and submit your votes.
(f)	End of remote participation	 Upon the announcement by the Chairman on the closure of the EGM, the live streaming will end.

Note to users of the RPV:

- 1. Should your application to join the EGM be approved, we will make available to you the rights to join the live-streamed meeting and to vote remotely. Your login to TIIH Online on the day of the EGM will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

POLL VOTING

- The voting at the EGM will be conducted by-poll in accordance with Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad.
- Members can proceed to vote on the resolutions at any time from the commencement of the EGM at 11.00 a.m. on Tuesday, 11 May 2021 or immediately after the Annual General Meeting 2021 of the Company but before the end of the voting session which will be announced by the Chairman of the meeting. - Upon completion of the voting session for the EGM, the Scrutineers will verify and announce the poll results followed by the Chairman's declaration whether the resolutions are duly passed.
